REPORT ON THE ONE AFRICA FREEDOM **DIALOGUE**

The **ONE AFRICA FREEDOM DIALOGUE**, was held on the 10th of October, 2020. under the topic, **ENSURING MAXIMUM ADHERANCE TO THE RULE OF LAW, IN THE AFRICAN ANATOMY**. The Forum was represented with Freedom Giants in **AFRICAN VOICES INTERNATIONAL**, and other Pan Africanists all over the world. The Conference was carried on to educate, empower, and create a sense of awareness to Africans on the Rule of Law, and to revive in them the Pan Africanist Spirit, to fight for **FREEDOM**, in their Political Anatomies to uphold **FREEDOM** in every geographical setting of Africa, they are.

AFRICAN VOICES INTERNATIONAL on her Goals of seeing to the Cross-validation of the Continent's Governance believes that the various Governments of our African Countries can only thrive, when Africanists raise their voices on how the Governments should be led. **AFRICAN VOICES INTERNATIONAL** believes in Africa, as the preferred destination for a vibrant Democracy and Good Quality in Governance.

CONCEPT OF THE RULE OF LAW, AND HOW IT WORKS

The rule of Law is a codified set of laws, promulgated in a constitution that ensures that the administration of a country is altered in a just and fair way, that ensures that no one is superior to the laws of the particular Political Anatomy, all for the freedom of the particular Political Anatomy.
